London Health Sciences Foundation (LHSF) Country Classic Auction (CCA) #NBFullAccess Rules and Regulations

- 1. To enter and to be eligible to win, entrants must be eighteen (18) years of age or older. Employees of LHSF and their parents, siblings and children and persons domiciled with them are ineligible to enter.
